Limited Warranty for Residential Coastal Collection Doors
General Information

Fimbel Architectural Door Specialties manufactures the Amarr Residential Coastal Collection sections using Vinyl Composite Technology (VCT). Fimbel Architectural Door Specialties warrants to the original purchaser that Fimbel Architectural Door Specialties will repair or replace sections that are defective in material or workmanship pursuant to the terms of this limited warranty for one (1) year from the date of purchase.

These warranties extend to normal usage when the door has been finished, installed and maintained in accordance with manufacturer's instructions. The warranties do not apply to any damage or deterioration caused by abuse or misuse, failure to provide reasonable and necessary maintenance as defined by manufacturer's maintenance and installation instructions, improper installation or handling of garage door or electric garage door opener, fire, hail, flood, wind or any other acts of God, failure of paint applied after manufacture and distribution, alterations and/or additions to door, or environmental conditions, including, but not limited to: (1) areas subject to excessive salt atmosphere, (2) areas subject to fallout or exposure to corrosive chemicals, fumes, ash, cement dust, animal waste, or foreign substances, and (3) areas subject to water runoff from lead, copper, or galvanic metal flashing.

If within the applicable limited warranty period, the sections warranted are found to be defective upon inspection by authorized Fimbel Architectural Door Specialties personnel, Fimbel Architectural Door Specialties agrees to repair or replace, at Fimbel Architectural Door Specialties option, the defective door sections. Proof of purchase is required. Any charges for freight, removal, installation, or labor shall be the responsibility of the original purchaser. REPAIR OR REPLACEMENT OF SPECIFIED PARTS IS THE SOLE REMEDY OFFERED BY THIS WARRANTY. IN NO EVENT, SHALL FIMBEL ARCHITECTURAL DOOR SPECIALTIES BE LIABLE FOR CONSEQUENTIAL OR INCIDENTAL DAMAGES CAUSED BY OR RESULTING FROM DEFECTIVE GARAGE DOOR SECTIONS OR HARDWARE.

ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING ANY WARRANTY OF MERCHANTABILITY, OR FITNESS FOR A PARTICULAR PURPOSE, ARE HEREBY EXPRESSLY EXCLUDED AND DISCLAIMED.

Some states do not allow the exclusion or limitations of incidental or consequential damages, so the above limitation or exclusion may not apply to you. This warranty gives you specific legal rights and you may also have other rights, which vary from state to state or province to province. To make a claim under this warranty, contact Fimbel Architectural Door Specialties immediately in writing at the address listed below. Please send a complete description and photograph of the issue. Response may take up to two weeks from receipt of warranty claim. Upon receiving the claim, Fimbel Architectural Door Specialties may, at its discretion, instruct the purchaser to return the specified door section or part(s) thereof to the nearest Amarr facility, shipping prepaid.

### **Limited Warranty for Amarr Coastal Collection Sections Manufactured by Fimbel Architectural Door Specialties**

If your Coastal Collection garage door sections crack, split or peel, Fimbel Architectural Door Specialties will repair or replace those sections for as long as you own the sections, providing the sections have been left natural white or painted with heat reflective vinyl-safe paint in strict accordance with the recommended paint instructions by Fimbel Architectural Door Specialties. If sections have been factory-pre-drilled for decorative clavos and clavos are not installed, section damage from failure to install the clavos will void the warranty. Please refer to Finishing Instructions below.

### **Limited Warranty for Amarr Hardware for Amarr Coastal Collection**

Amarr Garage Doors warrants to the original purchaser that if any part or hardware (excluding exterior decorative hardware) supplied by Amarr for Amarr Coastal Collection Garage Doors is defective in material or workmanship, we will repair or replace it for (3) three-years from the date of purchase. The three-year hardware warranty applies to standard lift and low headroom applications only (not to high-lift or vertical lift) and only when utilizing 15", 20" or 32" radius track.

### **Cleaning Instructions for Amarr Coastal Collection Sections**

In order to ensure years of trouble-free performance, the face and edges of the Coastal Collection sections are UV-resistant and may be left in their natural white color. For general cleaning, use warm water and a dishwashing liquid soap. DO NOT use cleaners containing acid or solvents like MEK, acetone or Toulon. For more stubborn situations, Soft Scrub, Clorox Cleanup or Clorox Outdoors can be used. Be sure to scrub with the grain of the surface. For the most stubborn of stains, lightly sand with 200 to 220 grit paper, and always sand with the grain. The door surfaced can be wiped with denatured alcohol to remove any soap, cleaner residue or dust.

### **Finishing Instructions for Amarr Coastal Collection Sections**

Failure to follow the recommended finishing instructions MAY lead to premature failure of the sections and voids the section warranty. Clean sections by following cleaning instructions below. Finish sections using either of the listed options: (1) Sherwin Williams VINYLSAFE Resilience paint system for standard colors only is the recommended heat reflective paint for the Coastal Collection sections. This heat reflective paint system is specifically formulated to bond to vinyl surfaces and reflect the sun's rays off the vinyl surface, cooling and protecting the surface and allows for a wide range of color choices. Sherwin Williams VINYLSAFE Resilience custom mixed colors will void warranty. (2) The Coastal Collection sections are available with a professionally applied, pre-finished paint or stain color. These paint and stains are high performance, heat-reflective vinyl paints and gel stains that have a 15-year warranty from the paint manufacturer. Use of any paint or stain finish other than the two recommended options mentioned above is done at the customer's risk. Damage resulting from failure to follow these finishing instructions will void the warranty.
